


"Protection of Natural Resources of the Natural Protected Area (NPA) of Colima, El Salvador" ALFALIT, El Salvador

The situation: Population growth in the communities bordering the NPA of Colima causes strong pressure and consequently exploitation of natural resources: deforestation for fuel wood consumption, stone extraction for construction, introduction of cattle, reptile hunt and endangered species threatened with extinction, lack of sustainable alternatives to farmers, forest fires and lack of organization in the same community, are only examples of the great causes that provoke the serious deterioration of the Natural Resources in that country's ecosystem.

Community managed natural resources: reducing risks and strengthening livelihoods

Best practices

The solution: ALFALIT, works in this territory, with the purpose of developing actions for the protection and improvement of infrastructure and ecosystems of the Natural Protected Area of Colima, through the Strengthening of Capacities of the inhabitants of the communities, the promotion of environmental education from the School Centers of the area, and training on recycling, school gardens, cleaning days; risk prevention training in communities and formation of risk committees; creation and demonstration of diversified plots for farmers; and support to promote eco-tourism. These actions contribute to the number one objective of the Sendai Framework on Disaster Risk Reduction, referring to "Understanding Disaster Risk" and priority #3 "Investing in Disaster Risk Reduction for Resilience"



The Results: The project is implemented in the Canton of Colima, municipality of Suchitoto, department of Cuscatlán. With 6,296 people from four communities and four schools benefited. ALFALIT has contributed to the process of organizing the communities and local organizations benefiting from the project, in order to articulate and strengthen the processes, thus achieving: Promotion of environmental education to 280 students of the schools around the Natural Protected Area NPA; annual cleaning days in the four communities; creation of intercommunal committee of the surrounding communities; protection of at least six species of endangered animals; structural improvements in four booths, three lookout points, one watch tower and promotion of ecotourism at a national level.
